## Funds Flow Workgroup Charter Members

### Funds Flow Workgroup Purpose

The purpose of the Funds Flow Workgroup is to advise the Board of Directors regarding the high-level flow of Medicaid Transformation Project funding including allocation to partners and payment models.

### **Funds Flow Workgroup Principles**

- The Treasurer of the Board of Directors shall chair the Funds Flow Workgroup
- Workgroup members shall have representation of the three counties, Tribes, and a variety of sectors.
- Workgroup members should have background in Medicaid Transformation Project requirements and Funds Flow decisions. OCH staff can support interested members in obtaining this knowledge level if needed.
- A majority of the Funds Flow Workgroup members shall be necessary and sufficient at all meetings to constitute a quorum for the transaction of business
- The Funds Flow Workgroup shall be accountable to the OCH Board of Directors and will present recommendations and actions for review

### Responsibilities

- Work with OCH Staff to understand updates to Medicaid Transformation Project funding
- Develop recommendations and guidance to the Board of Directors
- Establish and regularly review a high-level funds flow strategy for Medicaid Transformation Project funding
- Recommend an annual payment model for each year of the Medicaid Transformation Project which details how funds are to be allocated to partners
- Establish principles for unallocated Medicaid Transformation Project funding

### Timeline

The Funds Flow Workgroup shall meet as needed.
